A. ORGANIZATION The Milan Junior Camp of Cortina d'Ampezzo (BL), Jesolo Lido (VE), Medulin / Pola (Hr) and Vittorio Veneto (TV) are organised by Sporteventi Tel.: +39 0438 941366 - Mobile +39 348 8746938 - Fax +39 0438 947394

B. MILAN JUNIOR CAMP. It is the typical camp, with accommodation in the hotel for the participants. The subscription cost of the week rotation period of the Milan Junior Camp is of Euro 710,00 for Vittorio Veneto, Jesolo Lido and Medulin, and of Euro 725,00 for Cortina d'Ampezzo; it includes staying, meals and accommodation from Sunday afternoon until Saturday at 2pm, daily wash of t-shirts- personal badge with photograph. transportation by private coach to and from the football pitch and the subscription amount for joining the Camp. Prices are all inclusive except for telephone calls and drinks. The subscription amount includes a weekly accident insurance.

C. MILAN DAY CAMP. These are the Milan Junior Camp without staying overnight, envisaged for those who can reach the site of the Camp, Vittorio Veneto, Jesolo Lido, Medulin (Pula/Hr) or Cortina d'Ampezzo every day. The subscription cost including lunch from Monday to Saturday is of 530,00 Euro for Jesolo Lido, Medulin (Pula/Hr) and Vittorio Veneto is of Euro 550,00 for Cortina d'Ampezzo. This include daily wash of t-shirts- personal badge with photograph. transportation by private coach to and from the football pitch. plus a weekly accident insurance and the subscription amount for joining the Camp. Prices are all inclusive except for telephone calls and drinks.

D. The applicants can in no case be received by Sporteventi staff prior to Camp start time (which is 2 pm Sunday); parents and/or accompanying persons will have to look after their children (including supervision and lunch) until the actual start time of the Camp, even if they arrive at the hotel on Sunday morning.

E. PAYMENT CONDITION. At the time of subscription a down payment should be necessarily made of 300 Euro (three hundred), the outstanding amount should be paid 10 days before the beginning of the selected period. Payment can be done (ALWAYS QUOTING THE REASON FOR THE PAYMENT) with a money order to SPORTEVENTI: SPORTEVENTI, C/C no. 43839 at Banca di Credito Cooperativo delle Prealpi - Filiale di Vittorio Veneto (IBAN Code IT 55 X 08904 62190 007000043839 BIC Code ICRAITRRP40).

F. CALL OFF. The down payment will be returned upon cancellation by the subscriber only if notified in writing by fax at least 30 days before the start of the selected period.

G. ACCOMODATION. Who wishes to participate to two consecutive periods, at the

time of registration a down payment should be paid and further 95 Euro for Saturday dinner and night accommodation and for Sunday breakfast and lunch and overseeing during that time.

H. HEALTH CERTIFICATE. Please provide together with this application form a medical certificate stating your good health conditions not older than one year before camp starting date; for those who already practice a competitive sport, we require just a copy of the Health Certificate of fitness to practice sports.

I. RELIEF FROM RESPONSIBILITY. I the undersigned _____ parent of _____ who is a minor, under my personal responsibility declare to relieve SPORTEVENTI and all its staff and/or appointed person, from any responsibility for damages occurred to my son. In particular the undersigned _____ relieve SPORTEVENTI from all liabilities due to damages of the psychological/physical injuries that his/her son/daughter should suffer during the sport stage as well as of any other possible damage of whatever nature that could occur during said stage. I furthermore declare to relieve SPORTEVENTI and any member of its staff or appointed person from any responsibility for damages that the boy/girl should cause during the stage of the Milan Camp.

J. EXPRESS CANCELLATION CLAUSE: In the event that during the time at the CAMP as well as during the stay in the hotel, the registrant's behavior breaks in any way the normal rules of civil cohabitation or are against the rules given by the guides/trainers, then said registrant may be removed from the CAMP and this contract will be considered legally cancelled therefore SPORTEVENTI will be allowed to retain all amounts received by it and to legally demand compensation.
